Memorandum - goalie equipment inspection

In the course of NBLL 2023, rules regarding the inspection of goalie equipment will be put into practice. See below for details.

Time schedule:

- 1) Regular season of NBLL 2023 "informative phase"
 - a. Informative measurement will take place at selected games.
 - b. The goal will be for each goalkeeper to have time to correct and be informed.
 - i. There will be an effort to check each goalkeeper several times during the regular part.
 - c. There will be no penalty for illegal equipment at this stage.
 - d. Any requests by coaches for inspection during the game will not be granted, as before.
- 2) FInal4 NBLL 2023 "hot phase"
 - a. The start of the official measurement with all the requisites and impacts.

Procedure in the "informative phase":

- 1) Referee Commission (KR) will email information to the teams' contact persons (received from the league management) 48 hours before the start of the game, stating that the game has been selected for inspection.
- 2) The measurement will always take place in private.
 - a. Optimally in the referees' dressing room or in another suitable place.
 - b. Referees, goalkeepers of one team and their coach may be present.
- 3) Measurement without equipment obtaining reference values.
 - a. This step takes place only once, if the reference values are not yet known.
 - b. Total height and shoulder width will be measured.
 - c. The data will be recorded in an "online" table, which will then be available to the referees.
 - d. This step must be timed before the goalkeeper puts on the equipment, ideally 45 minutes before the game.
 - e. If there is a request for a new measurement of the reference values, contact KR with a request at the address <u>csml.kr@lacrosse.cz</u>.
- 4) The measurement itself with equipment.
 - a. It will take place ideally 15 minutes before the game.
 - b. The result will be information for the goalkeeper, what is OK and what is not.

Procedure in the "hot phase":

- 1) The procedure will be identical to the information phase except for the following :
 - a. Information about pre-game inspection will not be sent out.
 i. Control is expected at each game.
 - b. The result will not be only information for the goalie, but will proceed according to the valid NBLL rules.
- 2) We would like to draw your attention to the possibility of a random inspection even during the game, as stipulated by the NBLL rules.
- 3) We appeal to all teams to start using two goalies for a game as standard.
 - a. In the case of only one goalie and his exclusion from the game, the following procedure is valid with reference to rule 6.8.4.:
 - i. A penalized goaltender may resume play after the equipment has been adjusted to be legal.
 - ii. A minor penalty for illegal equipment is served by inhome.
 - iii. A penalty shot is awarded against the offending team.
 - iv. With regard to possible abuse / obtaining an advantage through this procedure, the entire situation is reported to Disciplinary Committee (DK ČSML).
